#### Terms and Conditions

The Art House (Competition Runner)

Saturday 11<sup>th</sup> January, 2025.

By entering the competition, you agree to be bound by the following rules:

#### **Eligibility**

The Art House 80s Dress Up Competition is open only to visitors to The Art House during the competition period. Employees of The Art House and their suppliers, artists, or visiting companies (as well as their immediate family) are not eligible.

Participation constitutes the entrant's full and unconditional agreement to these Official Rules and the Competition Runner's decisions, which are final and binding in all matters related to the Competition and no correspondence or discussion shall be entered into. The Competition Runner reserves the right not to award a prize (and/ or to select an alternative winner) if the Competition Runner is aware or has reasonable grounds to believe that a winner is not eligible for any reason. Winning a prize is contingent upon fulfilling all requirements set forth herein. It is a condition of entry that all these Official Rules are accepted as final, and entrants agree to abide by these Official Rules.

#### **Timing**

Competition opens: Saturday 11<sup>th</sup> January 2025 7PM (AEDT)

Competition closes: Saturday 11<sup>th</sup> January 2025 10PM (AEDT)

#### **Entry method**

Entrants must post a photo clearly displaying their 80s themed outfits in front of The Art House media wall in The Art House foyer and share it to social media tagging @theartousewyong on Instagram or Facebook. Profile must be set to 'public' for an entry to be judged. Alternatively, photos can be submitted as a valid entry via email to [info@theartousewyong.com.au](mailto:info@theartousewyong.com.au) prior to the closing date of the competition.

#### **Selection process**

Of all entries, the entrant considered the most visible, creative, and 80s inspired will be determined by the Competition Runner (The Art House). The winner will be selected on Monday 13<sup>th</sup> January at 12PM and notified via their entry method – email, Instagram direct message, or Facebook direct message.

The winner will need to respond to the Competition Runner by Tuesday 14<sup>th</sup> January at 12PM to claim their prize. If the Competition Runner has not received a response from the winner by the date indicated above, they reserve the right to select another winner at random from those entered during the competition period.

The potential winner is subject to verification by the Competition Runner, whose decisions are final and binding in all matters related to the competition. An entrant is not a winner of any prize, even if

the competition should so indicate, unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete.

Receiving the prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason, Sponsor may award the applicable prize to an alternate winner by randomly drawing from among all remaining eligible entries.
